We take pride in our beautiful campground and to protect it for the future, please follow our rules and regulations that we have in place.

The campground is subject to flash flooding. At times it is necessary to vacate the campground due to the potential of flooding. The continuous horn blowing of a park vehicle will indicate that you must vacate the campground immediately.

**High-water/Flood Policy** – If the determination is made by state officials or the management of Bass' River Resort that the river levels are beyond safe canoeing or rafting standards, a credit certificate will be issued for the amount of your payment. (No Refunds).

Guests are responsible for knowing and following the rules listed below:

- Please register at the General Store before entering the campground. We require your vehicle license plate #.
- Check-out time: Camping — 12:00 p.m., Lodging — 11:00 a.m.
- Fires are restricted to grills provided.
- Do not drive nails or stick hatchets into trees. Do not hang lanterns from trees.
- No electric cords can be run from electric sites to non-electric sites.
- No firearms or bows allowed in the campground.
- No illegal drugs of any kind are allowed on the premises. Violators will be arrested and prosecuted.
- All branches of law enforcement are allowed to make unscheduled patrols of the campground. These streams are patrolled by the Missouri State Water Patrol.
- Campsites may not be left unattended for more than 12 hours.
- No visitors in the campground after 9:00 p.m.

- Pets must be kept on a leash at all times. Do not attach leashes to trees. Keep leash to a 10-ft. maximum length.
- Car passes must be displayed on your rearview mirror or dashboard and shown to Security for entry into the campground.
- Place trash bags in dumpsters. Loud Area: You must checkout at the General Store and have your campsites clean in order to get your deposit back. If you fail to check out with us or do not clean your campsite, your deposit will be forfeited.
- No chainsaws are allowed. NO cutting or marring of any trees. Firewood is sold at the General Store.
- Speed limit is 10 mph in the campground.
- Family section of the campground quiet hours begin at 11:00 p.m. and end at 6:00 a.m. No excessive noise of any kind after 11:00 p.m.
- Loud section of the campground quiet hours begin at 2:00 a.m. and end at 6:00 a.m. No excessive noise of any kind after 2:00 a.m.
- No ATVs, UTVs, dirt bikes or go carts allowed.
- Please abide by NO Trespassing signs and purple paint. Most property along the river is privately owned. Purple paint means no trespassing. Violators will be prosecuted.
- Contact a security attendant or seek assistance at the General Store with any issues/problems.
